Update 17: Peru - COVID-19 Surge Reported in Five Provinces

1/15/2022, 11:56:47 AM

- Arequipa, Camaná, Caravelí, Caylloma, and Islay are the five provinces that reported an increase in COVID-19 cases and another 71 throughout Peru
- 76 provinces out of 196 reported a surge in COVID-19 cases
- 18 have already exceeded their maximum peak of cases in the entire pandemic
- Omicron variant is responsible for the surge in COVID-19 cases in the country
- Currently, the country is under high alert level which is due to expire on January 16, 2022
- Peru reported 39,080 COVID-19 cases and 47 deaths on January 14, 2022
- **Reported COVID-19 stats for Peru:**
 1. Confirmed Cases: 2,512,789
 2. Deaths: 203,302 (8.09%)
 3. Vaccine Doses Administered: 52,286,639
 4. Fully Vaccinated: 22,088,234 (68.7%)

Impact level Definitions

Impact Level	Definitions
Immediate	Anticipated disruption intensity is critical, and occurrence is imminent - Supply Wisdom recommends considering immediate review and action.
High	Anticipated disruption intensity is high and/or disruption is likely to occur within 3 months - Supply Wisdom recommends being in a heightened state of readiness to take quick action and confirm response plans/protocols.
Moderate	Anticipated disruption intensity is moderate and/or likely to occur within 3 to 6 months - Supply Wisdom recommends reviewing current mitigation steps and being prepared to take proactive action if and when situation deteriorates further.
Low	Anticipated disruption intensity is low and/or may occur after 6 months - Supply Wisdom recommends taking proactive action if situation does not resolve in approved timeframe.
Informational	The event is pertinent information but does not have a current risk element associated with it.
