Update 56: Taiwan - COVID-19 Mask Mandate to Remain Effective Until July 30, 2022

- Taiwan's major economic sectors are steel, machinery, electronics, and chemical manufacturing
- The Central Epidemic Command Center (CECC) has announced to continue the current mask mandate requirements and other contingency measures through the month of July 2022
- Under the existing rules, people are required to wear a mask at all times when they are outside their homes, except in certain situations
- Exemptions for mask mandates include:
 - Indoor or outdoor exercise
 - Individual/group photos either indoors or outdoors
 - Driving alone or with family members
 - Individual/group live broadcasts, video recordings, show hosting, reporting, speeches, lectures, and interactions while filming productions
 - Agriculture, forestry, fishery, and animal husbandry work in open areas
 - Mountain, forest (including forest recreation areas), and seaside activities
 - Hot/cold springs, saunas, spas, and steam rooms, as well as other situations where masks could get wet
- Those who have received three shots of the COVID-19 vaccine can perform mask-free exercises in the gym
- Businesses and public places should continue to measure body temperature, clean public areas, monitor employee health, and respond promptly to confirmed incidents
- Religious places and religious gatherings or events should follow epidemic prevention and control rules issued by the Ministry of Home Affairs

 - Confirmed Cases: 3,767,283
 - Deaths: 6,651 (0.2%)
 - Recoveries: 2,755,500 (73.1%)
 - Vaccine Doses Administered: 57,744,693
 - Fully Vaccinated: 19,324,925 (81.9%)

Impact Level Definitions

Impact Level	Definition
Critical	Anticipated disruption intensity is critical, and occurrence is imminent - Supply Wisdom recommends considering immediate review and action.
High	Anticipated disruption intensity is high and/or disruption is likely to occur within 3 months - Supply Wisdom recommends being in a heightened state of readiness to take quick action and confirm response plans/protocols.
Moderate	Anticipated disruption intensity is moderate and/or likely to occur within 3 to 6 months - Supply Wisdom recommends reviewing current mitigation steps and being prepared to take proactive action if and when situation deteriorates further.
Low	Anticipated disruption intensity is low and/or may occur after 6 months - Supply Wisdom recommends taking proactive action if situation does not resolve in approved timeframe.
Informational	The event is pertinent information but does not have a current risk element associated with it.
