Update 96: Ireland - COVID-19 Infections - Surge in Cases Reported

- Ireland's economy is majorly focused on the service sector including high-tech, life sciences, financial services, agribusiness, and others
- Ireland reported 1,995 COVID-19 cases on June 29, 2022
- Approximately, 776 people are in hospital and 31 people were in intensive care units (ICU) as of June 29, 2022
- 21 deaths have been reported due to the virus in the past 14 days
- 13,584 COVID-19 cases were reported in the past seven days, up from 10,008 a week before
- Currently, the country is in the middle of a COVID-19 wave which is driven by Omicron sub-variants
- Ireland announced its plans to reintroduce the mandatory COVID-19 face mask law
- **Reported COVID-19 stats for Ireland:**
 1. Confirmed Cases: 1,600,614
 2. Deaths: 7,467 (0.47%)
 3. Recoveries: 262,338 (16.39%)
 4. Vaccine Doses Administered: 10,974,893
 5. Fully Vaccinated: 4,041,506 (82.1%)

Impact Level Definitions

Impact Level	Definition
Critical	Anticipated disruption intensity is critical, and occurrence is imminent - Supply Wisdom recommends considering immediate review and action.
High	Anticipated disruption intensity is high and/or disruption is likely to occur within 3 months - Supply Wisdom recommends being in a heightened state of readiness to take quick action and confirm response plans/protocols.
Moderate	Anticipated disruption intensity is moderate and/or likely to occur within 3 to 6 months - Supply Wisdom recommends reviewing current mitigation steps and being prepared to take proactive action if and when situation deteriorates further.
Low	Anticipated disruption intensity is low and/or may occur after 6 months - Supply Wisdom recommends taking proactive action if situation does not resolve in approved timeframe.
Informational	The event is pertinent information but does not have a current risk element associated with it.
